Conformément à l'article 38, troisième paragraphe, la Convention entrera en vigueur pour la Zambie le 1^{er} novembre 2014.

Conformément à l'article 38, quatrième paragraphe, de la Convention, l'adhésion n'aura d'effet que dans les rapports entre la Zambie et les États contractants qui auront déclaré accepter cette adhésion.

Conformément à l'article 38, cinquième paragraphe, la Convention entrera en vigueur entre la Zambie et l'État ayant déclaré accepter cette adhésion le premier jour du troisième mois du calendrier après le dépôt de la déclaration d'acceptation.

Notification pursuant to Article 45 of the Convention

ACCESSION

Zambia, 26-08-2014

According to Article 38, third paragraph, the Convention will enter into force for Zambia on 1 November 2014.

According to Article 38, fourth paragraph, of the Convention, the accession will have effect only as regards the relations between Zambia and such Contracting States as will have declared their acceptance of the accession.

According to Article 38, fifth paragraph, the Convention will enter into force between Zambia and the State that has declared its acceptance of the accession on the first day of the third calendar month after the deposit of the declaration of acceptance.
