**AUSTRALIAN DECLARATION OF ACCEPTANCE OF ACCESSIONS OF  
THE REPUBLIC OF KOREA TO THE 1980 HAGUE CONVENTION ON THE  
CIVIL ASPECTS OF INTERNATIONAL CHILD ABDUCTION**

WHEREAS Australia is a Contracting State of the 1980 Hague *Convention on the Civil Aspects of International Child Abduction* (the Convention) and the Republic of Korea has acceded to that Convention but its accession will have effect only as regards the relations between it and such Contracting States of the Convention as will have declared acceptance of their accessions.

NOW THEREFORE THESE PRESENTS CERTIFY that THE AUSTRALIAN GOVERNMENT, FOR AND ON BEHALF OF AUSTRALIA, declares its acceptance of the Republic of Korea to the Convention.
