Her Britannic Majesty's Embassy presents its compliments to the Ministry of Foreign Affairs of the Kingdom of The Netherlands and has the honour to advise the Ministry of Foreign Affairs that the United Kingdom of Great Britain and Northern Ireland declares that it accepts the accession of Andorra to the Hague Convention of 25 October 1980 on the Civil Aspects of International Child Abduction, in accordance with Council Decision (EU) 2015/1023.

The United Kingdom of Great Britain and Northern Ireland also accepts the accession of the Principality of Andorra for the following territories for whose international relations the United Kingdom is responsible: Anguilla, Bermuda, Cayman Islands, Falkland Islands, Isle of Man, Jersey and Montserrat.

In accordance with Article 38 of the Convention, the United Kingdom will give effect to the accession of the Principality of Andorra from 1 July 2016.

Her Britannic Majesty's Embassy avails itself of the opportunity to renew to the Ministry of Foreign Affairs of the Kingdom of The Netherlands the assurance of its highest consideration.
