DECLARATION

WHEREAS the Government of Montenegro has deposited a notification on succession for the Convention on the Civil Aspects of International Child Abduction, which was concluded at the Hague 25 October 1980,

BEARING IN MIND stipulations contained in Article 38 of the mentioned Convention,

NOW THEREFORE I, Filip Vujanović, the President of Montenegro, affirm the following Declaration:

"Montenegro declares that, in accordance with article 38 paragraph 4 of the Convention, Montenegro accepts the accession of the Russian Federation to the Convention of the Civil Aspects of International Child Abduction, concluded at the Hague on 25 October 1980"

IN WITNESS WHEREOF, I have signed this Declaration at Podgorica on this seventh day of November twenty sixteen.
