The United Kingdom of Great Britain and Northern Ireland also accepts the accession of Jamaica to the Convention for the following territories for whose international relations the United Kingdom is responsible: Anguilla, Bermuda, Cayman Islands, Falkland Islands, Isle of Man, Bailiwick of Jersey, and Montserrat.


In accordance with Article 38 of the Convention, the United Kingdom will give effect to the accession of Jamaica from 1 November 2023.
