The Embassy of Hungary presents its compliments to the Ministry of Foreign Affairs of the Kingdom of the Netherlands, and has the honour to inform the esteemed Ministry, as the depository of the Convention on the civil aspects of international child abduction (concluded on 25 October 1980), about the following.

According to Article 38 paragraph 4 of the Convention, the accession will have effect only as regards the relations between the acceding State and such Contracting States as will have declared their acceptance of the accession.

Hungary declares that it accepts the accession of the Republic of Tunisia to the Hague Convention of 25 October 1980 on the Civil Aspects of International Child Abduction, in accordance with Council Decision (EU) 2022/2450.

Hungary declares that it accepts the accession of the Republic of the Philippines to the Hague Convention of 25 October 1980 on the Civil Aspects of International Child Abduction, in accordance with Council Decision (EU) 2022/2439.

The Embassy of Hungary avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Kingdom of the Netherlands the assurances of its highest consideration.
