ACT OF ACCESSION  
TO THE CONVENTION FOR THE PACIFIC SETTLEMENT  
OF INTERNATIONAL DISPUTES

**WHEREAS**, the Convention for the Pacific Settlement of International Disputes (hereinafter referred to as “the Convention”) was concluded at The Hague on July 29, 1899,

**AND WHEREAS**, pursuant to a decision of the Administrative Council of the Permanent Court of Arbitration, all Member States of the United Nations Organization that do not yet participate in the activities of the Permanent Court of Arbitration were invited to accede to the Convention,

**AND WHEREAS**, the Government of the Republic of Armenia has decided that the Republic of Armenia shall become a Party to the Convention.

**NOW THEREFORE**, the Government of the Republic of Armenia, having considered the Convention for the Pacific Settlement of International Disputes concluded at The Hague on July 29, 1899, declares that hereby the Republic of Armenia **ACCEDES** to the Convention and undertakes to carry out faithfully the provisions therein contained.

**IN WITNESS WHEREOF**, I, Ararat Mirzoyan, Minister of Foreign Affairs of the Republic of Armenia, have signed this Act of Accession and affixed my official seal.
