The Slovak Republic declares its acceptance of the accession of the Principality of Andorra to the said Convention.

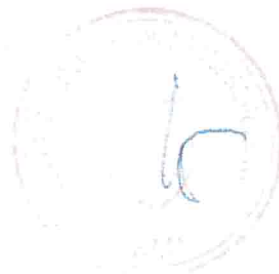
In this context the Embassy kindly requests the depositary to provide the information about the date of entry into force of the said Convention between the Slovak Republic and the Principality of Andorra.
