DECLARATION OF ACCEPTANCE

The Ministry of Justice presents its compliments to the Royal Netherlands Embassy and has the honour to refer to the accession of Armenia, Colombia, Costa Rica, Kazakhstan, Republic of North Macedonia, Montenegro and Nicaragua to the Convention on the Taking of Evidence Abroad in Civil or Commercial Matters, done at the Hague on 18 March 1970.

Pursuant to Article 39, paragraph 4, of the Convention Finland hereby accepts the accession of Armenia, Colombia, Costa Rica, Kazakhstan, Republic of North Macedonia, Montenegro and Nicaragua to the Convention in respect of Finland.

The Ministry of Justice requests the Embassy to notify it of the dates on which the Convention will enter into force as between Finland and the State referred to above.
