Her Britannic Majesty's Embassy presents its compliments to the Ministry of Foreign Affairs of the Kingdom of The Netherlands and has the honour to advise the Ministry of Foreign Affairs that the United Kingdom of Great Britain and Northern Ireland declares that it accepts the accession of the Republic of Croatia, the Republic of Hungary, the Republic of Lithuania, the Republic of Malta, Romania, and the Republic of Slovenia to the Hague Convention on the Taking of Evidence Abroad in Civil or Commercial Matters of 18 March 1970 ("the Convention").

The United Kingdom and Northern Ireland also accepts the accession of the Republic of Croatia, the Republic of Hungary, the Republic of Lithuania, the Republic of Malta, Romania, and the Republic of Slovenia for the following territories for whose international relations the United Kingdom is responsible:

The Bailiwick of Jersey

The Bailiwick of Guernsey

The Isle of Man

The Sovereign Base Areas of Akrotiri and Dhekelia

Cayman Islands

Falkland Islands

Gibraltar

In accordance with Article 39 of the Convention, the United Kingdom will give effect to the accession of the Republic of Croatia, the Republic of Hungary, the Republic of Lithuania, the Republic of Malta, Romania, and the Republic of Slovenia on the sixtieth day after the deposit of this instrument.

Her Britannic Majesty's Embassy avails itself of the opportunity to renew to the Ministry of Foreign Affairs of the Kingdom of The Netherlands the assurance of its highest consideration.
