The Ministry of Foreign Affairs of the Republic of Singapore presents its compliments to the Embassy of the Kingdom of the Netherlands and has the honour to inform the latter that with reference to Article 39 paragraph 4 of the Convention of the Taking of Evidence Abroad in Civil or Commercial Matters concluded at the Hague on 18 March 1970, the Republic of Singapore declares its acceptance of the accessions, of the States listed in the Annex, to the Evidence Convention.

In accordance with Article 39, the said Convention will enter into force between Singapore and each of the thirty abovementioned States on the sixtieth day after deposit of this declaration of acceptance.

The Ministry of Foreign Affairs of The Republic of Singapore avails itself of this opportunity to renew to the Embassy of the Kingdom of the Netherlands the assurances of its highest consideration.
