The Ministry of Foreign Affairs of the Republic of Singapore presents its compliments to the Embassy of the Kingdom of the Netherlands and has the honour to inform the latter that with reference to Article 39 paragraph 4 of the Convention of the Taking of Evidence Aboard in Civil or Commercial Matters concluded at the Hague on 18 March 1970 (“the Evidence Convention”), the Republic of Singapore declares its acceptance of the accessions of the following States to the Evidence Convention: (i) Georgia; (ii) the Republic of El Salvador; and (iii) the Republic of Paraguay.

In accordance with Article 39, the Evidence Convention will enter into force between Singapore and each of the abovementioned States on the sixtieth day after the deposit of this declaration of acceptance.

The Ministry of Foreign Affairs of the Republic of Singapore avails itself of this opportunity to renew to the Embassy of the Kingdom of the Netherlands the assurances of its highest consideration.
