Her Britannic Majesty's Embassy presents its compliments to the Ministry of Foreign Affairs of the Kingdom of The Netherlands and has the honour to advise the Ministry of Foreign Affairs that the United Kingdom of Great Britain and Northern Ireland declares that it accepts the accession of the Republic of Albania, the Republic of Estonia, the Republic of Moldova, and the Republic of Poland to the Hague Convention on the Recognition of Divorces and Legal Separations of 1 June 1970 ("the Convention").

The United Kingdom and Northern Ireland also accepts the accession of the Republic of Albania, the Republic of Estonia, the Republic of Moldova, and the Republic of Poland for the following territories for whose international relations the United Kingdom is responsible:

The Bailiwick of Jersey

The Bailiwick of Guernsey

The Isle of Man

Bermuda

Gibraltar

In accordance with Article 28 of the Convention, the United Kingdom will give effect to the accession of the Republic of Albania, the Republic of Estonia, the Republic of Moldova, and the Republic of Poland on the sixtieth day after the deposit of this instrument.

Her Britannic Majesty's Embassy avails itself of the opportunity to renew to the Ministry of Foreign Affairs of the Kingdom of The Netherlands the assurance of its highest consideration.
