#### ACCESSION

Bahamas, 14-04-2016

The Convention will, in accordance with its Article 95, enter into force for the Bahamas on 13 June 2016.

TO ALL TO WHOM THESE PRESENTS MAY COME GREETING

INSTRUMENT OF ACCESSION

WHEREAS the Permanent Court of Arbitration was established as the first global mechanism for the

settlement of disputes between States by treaty at the First International Peace Conference which was adopted

at the Convention for the Pacific Settlement of International Disputes was concluded at The Hague on 29th

July, 1899 and revised at the Second Hague Peace Conference on 18th October, 1907 by the adoption of a

Second "Convention for the Pacific Settlement of International Disputes;"

AND WHEREAS Article 20 of the Treaty specifies that, with the objective of facilitating an

immediate recourse to arbitration for international differences which it has not been possible to settle by

diplomacy, the signatory Powers undertake to organize a Permanent Court of Arbitration, accessible at all

times and operating, unless otherwise stipulated by the parties, in accordance with the rules of procedure

inserted in the present Convention. Instruments of accession shall be deposited with the Secretary General of

the Permanent Court of Arbitration;

NOW THEREFORE, the Government of the Commonwealth of The Bahamas, having considered

the Treaty, hereby ACCEDES to the same and undertakes faithfully to perform and carry out all the

stipulations therein contained.

IN WITNESS THEREOF, I, the Honourable Frederick A. Mitchell M.P., Minister of Foreign Affairs

and Immigration of the Commonwealth of The Bahamas have hereunto set my hand and affixed my seal.
