ACT OF ACCESSION
TO THE CONVENTION FOR THE PACIFIC SETTLEMENT OF INTERNATIONAL
DISPUTES

WHEREAS, the Convention for the Pacific Settlement of International Disputes (herein-
after referred to as “the Convention”) was concluded at The Hague on October 18, 1907,

AND WHEREAS, pursuant to a decision of the Administrative Council of the Permanent
Court of Arbitration, all Member States of the United Nations Organization that do not yet
participate in the activities of the Permanent Court of Arbitration were invited to accede to
the Convention,

AND WHEREAS, the Government of the Republic of Vanuatu has decided that the
Republic of Vanuatu shall become a Party to the Convention.

NOW THEREFORE, the Government of the Republic of Vanuatu, having considered the
Convention for the Pacific Settlement of International Disputes concluded at The Hague on
October 18, 1907, declares that hereby the Republic of Vanuatu **ACCEDES** to the
Convention and undertakes to carry out faithfully the provisions therein contained.

IN WITNESS WHEREOF, I, Matai Seremaiah, Deputy Prime Minister and Minister of
Foreign Affairs of the Republic of Vanuatu, have signed this Act of Accession and affixed
my official seal.
