#### **ACT OF ACCESSION**

# TO THE CONVENTION FOR THE PACIFIC SETTLEMENT OF INTERNATIONAL DISPUTES

**HAVING REGARD** to the Convention for the Pacific Settlement of International Disputes, done at The Hague on 18 October 1907 (the **Convention**);

CONSIDERING that, pursuant to a decision of the Administrative Council of the Permanent Court of Arbitration, all Member States of the United Nations Organisation that do not yet participate in the activities of the Permanent Court of Arbitration were invited to accede to the Convention;

**REAFFIRMING** the important role of the Permanent Court of Arbitration in the peaceful resolution of disputes;

WHEREAS, the Government of the Democratic Republic of Timor-Leste has decided that the Democratic Republic of Timor-Leste shall become a Contracting Party to the Convention;

**NOW, THEREFORE**, the Government of the Democratic Republic of Timor-Leste, having considered the Convention for Pacific Settlement of International Disputes concluded at The Hague on October 18, 1907, declares that the Democratic Republic of Timor-Leste hereby accedes to the Convention and undertakes to carry out faithfully all the provisions contained therein contained.

IN WITNESS WHEREOF, I, Kay Rala Xanana Gusmão, the Prime Minister of the Democratic Republic of Timor-Leste, have signed this Act and affixed my official seal.
