Convention respecting the laws and customs of war on land
(The Hague, 18 October 1907)

ACCESSION

State of Palestine, 02-04-2014

In accordance with Article 6, the State of Palestine deposited its instrument of accession to the above-mentioned Convention with the Ministry of Foreign Affairs of the Kingdom of the Netherlands on 2 April 2014. A certified true copy of the original instrument of accession is enclosed with this notification.

The Convention will, in accordance with its Article 7, enter into force for the State of Palestine on 1 June 2014.

The Ministry of Foreign Affairs of the Kingdom of the Netherlands sends the present notification in its capacity as depositary of the Convention respecting the laws and customs of war on land.

WHEREAS the Hague Convention (IV) respecting the Laws and Customs of War on Land and its annex: Regulations Concerning the Laws and Customs of War on Land was concluded in the Hague on 18 October 1907,

NOW THEREFORE I, Mahmoud Abbas, President of the State of Palestine declare that the Government of Palestine, having considered the above-mentioned treaties, accede to the same and undertake faithfully to perform and carry out the stipulations therein contained.
