Notification conformément à l'article 65 de la Convention

ENTRÉE EN VIGUEUR

La République du Botswana a déposé son instrument d'adhésion à la Convention susmentionnée le 14 novembre 2022 auprès du Ministère des Affaires Étrangères du Royaume des Pays-Bas, en conformité de l'article 58, troisième paragraphe, de la Convention. L'adhésion a été communiquée aux États contractants par la notification dépositaire [Recouvrement international des aliments destinés aux enfants No. 06/2022](#) du 15 novembre 2022.

Un État contractant a élevé une objection à l'adhésion de la République du Botswana avant le 16 novembre 2023, à savoir les États-Unis d'Amérique, dont la déclaration est donnée ci-dessous. Par conséquent, la Convention n'entrera pas en vigueur entre la République du Botswana et cet État contractant.

Conformément à l'article 60, deuxième paragraphe, sous b, la Convention est entrée en vigueur entre la République du Botswana et les autres États contractants, qui n'ont pas élevé d'objection à l'encontre de l'adhésion de la République du Botswana, le 16 novembre 2023.

Notification pursuant to Article 65 of the Convention

ENTRY INTO FORCE

The Republic of Botswana deposited, in accordance with Article 58, third paragraph, of the above-mentioned Convention, its instrument of accession to the Convention with the Ministry of Foreign Affairs of the Kingdom of the Netherlands on 14 November 2022. The Contracting States were informed of the accession by depositary notification [International recovery of child support No. 06/2022](#) on 15 November 2022.

One Contracting State raised an objection to the accession of the Republic of Botswana before 16 November 2023, namely the United States of America, whose declaration is given below. Therefore, the Convention will not enter into force between the Republic of Botswana and the above-mentioned Contracting State.

In accordance with Article 60, second paragraph, sub-paragraph b, the Convention entered into force between the Republic of Botswana and the other Contracting States which have not raised an objection to the accession of the Republic of Botswana, on 16 November 2023.
